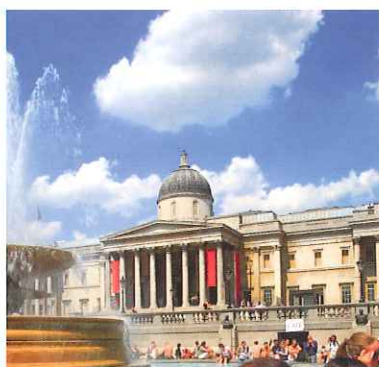

Delivery Sustainable Solutions to Global Challenges

Today's financial crisis and the ensuing recession we are now experiencing provides the backdrop to other important global issues that need to be addressed without delay, notably climate change, the ever-increasing demand for energy, the need for investment in infrastructure in emerging economies, and mass urbanisation.

To tackle the challenges effectively, the world needs the leadership, experience and creativity of the engineering community. If we can position ourselves to take the lead, mobilise our resources and apply our expertise and knowledge we will be able to deliver sustainable solutions and help lead society away from recession.

FIDIC 2009 London explores the role of engineers in the delivery of sustainable solutions to our global challenges. The aim will be to identify and plan the actions needed to position the consultancy and engineering industry as a leader in providing viable and effective solutions.

The conference takes place in London, one of the world's most remarkable and exciting cities. Truly global, London reaches out to embrace diverse people and cultures. Built on centuries of trade, talent and ideas, it has grown to be well-connected, cosmopolitan and culturally open. The city encompasses the best the world has to offer – cutting edge arts and culture, a world leader in business and commerce, year-round sports and events, cuisine and entertainment.

FIDIC 2009 London starts with a Welcome Reception in the historic Royal Courts of Justice on Sunday evening, 13 September 2009. Her Royal Highness Princess Anne, is the invited guest of honour for the Opening Ceremony on Monday, 14 September, which will be held in the award-winning Queen Elizabeth II Conference Centre that is uniquely situated in the shadow of Big Ben, the Houses of Parliament, Westminster Abbey and the London Eye.

Under the theme *Industry Challenges and Responses*, the business programme gets underway with leading personalities reviewing the global challenges and the need for action. Monday afternoon's three parallel business sessions will address the plenary theme in more detail. To encourage participation and discussion, following comments by panelists, the floor will be turned over to the participants. For the Monday local colour night, participants will be able to enjoy a buffet dinner cruise on the Thames on board the spectacular Silver Sturgeon.

Under the theme *Geographic and Sector Hot Spots*, the Tuesday morning's plenary session will examine regions and sectors where there are the best opportunities for our industry to lead. The business sessions that follow will focus on specific regions and sectors needing massive investments in infrastructure.

On Tuesday afternoon, business sessions will explore how to create *A More Agile, Responsive, High Profile Industry* to ensure that engineers take the lead in solving the global challenges. Wednesday morning will focus on the role of FIDIC and its members associations and firms in positioning the engineering community to be at the forefront of delivering sustainable solutions to global challenges. Speakers will review what the industry is currently doing, is planning to do, and should be doing to ensure that engineers will lead the way.

The FIDIC General Assembly Meeting takes place on Wednesday afternoon, and the closing gala banquet in The Great Room of the Grosvenor House Hotel on Park Lane will give an unforgettable taste of what it is like to attend one of the high-profile celebrity events that are held in Europe's largest banqueting venue.

Throughout the conference there is a lively and entertaining series of optional events and tours, and a full programme is offered for accompanying persons.

FIDIC and the local hosts, Association for Consultancy and Engineering, look forward to welcoming you in London for FIDIC 2009.

Conditions and Information

Venue: the conference venue is the Queen Elizabeth II Conference Centre (Broad Sanctuary, Westminster, London SW1P 3EE; tel: +44-20-72 22 50 00; fax: +44-20-77 98 42 00; www.qeicc.co.uk). It is only minutes away from both Victoria and Waterloo mainline stations, with easy access to St. Pancras for connections to Northern France, Brussels and Paris. The Underground links from Westminster and St. James's Park are just a few minutes away, providing direct access to the rest of London. The Opening Ceremony and the conference business programme take place at the Centre; events taking place elsewhere are: Welcome Reception (Royal Courts of Justice); optional Local Colour Night dinner cruise (Silver Sturgeon); Gala Dinner (Grosvenor House Hotel).

Registration: online registration with payment by credit card is available until the start of the conference at www.fidic2009.org; offline registration is available on site. All payments must be settled on seeking access to the conference, or access may be denied. Registration is as follows: Saturday, 12 September (14.00 - 18.00) and Sunday, 13 September (09.00 - 18.00), FIDIC Secretariat, Grosvenor House Hotel; Monday - Wednesday, 14 - 16 September (08.00 - 18.00), FIDIC 2009 Secretariat, QE II Conference Centre. Registration at the reduced "early bird" rate ends on 15 July 2009. Late registration after 5 September 2009 via FIDIC is subject to a 10% service charge. Payment by bank transfer may be accepted, upon request, in special cases. Registrations for the full conference can be exchanged once each day between participants from the same organisation by presenting the registration badge at the FIDIC 2009 Secretariat.

Events and tours: bookings and payment for optional events and tours, and for extra tickets to conference events, must be paid in full by 5 September 2009, and for the conference-organised post-conference tours by 24 July 2009. The cut-off dates for hotel reservations, subject to availability, made at the conference rates are listed in the hotel reservation form. Conference badges should be worn at all times during conference events and the business programme and when using conference buses.

Discounts: participants aged 35 years or less who work for a member firm of a FIDIC Member Association can register for the full conference with a 33% Young Professionals discount. Proof of age must be sent to FIDIC with the offline registration form or separately for online registration. There is also a discount on the full-conference fee for participants from FIDIC Member Association member firms based in Less Developed Countries (LDC). To obtain the LDC discount, the participant's national Member Association must be asked to notify FIDIC. For online registration, if a discount is applied for, the only method available for payment is "later by credit card": when FIDIC receives the registration it will send an invoice for payment.

Confirmation: the organisers will acknowledge the receipt and confirmation of conference registrations by fax or email. Requests for tours and event bookings will be handled on a first come, first served basis. While every effort will be made to keep to the published programme, the organisers reserve the right to change times and venues. Tours and events are based on a minimum of participants and may be either merged with an equivalent tour or cancelled. Conference participants and accompanying persons are encouraged to apply for visas as soon as possible. Please contact ACE for assistance.

Accompanying Persons Programmes can only be purchased with full conference and one-day registrations. The availability of places for the social programme is not guaranteed.

Cancellations and registration changes: partial or full cancellations of registrations received in writing before 15 July 2009 by mail or fax will be refunded less an administration fee (pro rata, based on GBP 100 for a full-conference registration) if payment is also received by this date. Payments and cancellations received between 15 July 2009 and 5 September 2009 will be entitled to a 50% refund. No refunds are available for payments received after 5 September 2009. Refunds will be processed after the conference.

Hotels: the main conference hotel is the Grosvenor House Hotel, Park Lane. Meetings before the conference will be held in 86 Park Lane adjoining the hotel. The nearest Underground stations are Marble Arch and Bond Street and the journey time to the conference venue is 25 minutes (10 minutes walk to Bond Street; then 10 minutes by Underground to Westminster followed by a short walk). Conference rates are also available at two conference hotels, the Crowne Plaza London - St James (a five-minute journey by Underground from the conference venue), and the Strand Palace Hotel (a few minutes walk from the conference venue). There will be bus transfers and shuttle buses from the Grosvenor House and the Crowne Plaza and the conference venue. For the Welcome Reception, buses will be available for the Grosvenor House and the Crowne Plaza and for the Gala Dinner, buses will be available for the Crowne Plaza and the Strand Palace. Buses for optional tours will leave from the QE II Conference Centre, and post-conference tours from the Grosvenor House.

Hotel accommodation: for the five-star Grosvenor House Hotel, the main conference hotel, there are special conference rates for 9 - 17 September 2009. Reservations can be made online (use Group Code "ACEACEA") or by contacting Eszter Gubis (eszter.gubis@marriott-hotels.com; tel +44-20-73 99 81 29; fax +44-20-73 99 85 60, quoting "FIDIC-ACE". For bookings that include other dates, it is necessary to make multiple online bookings, or contact the hotel. Bookings are guaranteed by a one-night deposit by credit card or by bank transfer. For reservations at the four-star Crowne Plaza and the three-star Strand Palace, contact the hotel or book through The Corporate Team (tel: +44-20-75 92 30 65; qeiihotels@corporateteam.com; quote event number "7777ACE"). Reservations through The Corporate Team must

be guaranteed by credit card (card details are passed on to the hotel). Payment can be by cheque, bank draft or bank transfer (contact The Corporate Team). Participants should check with the hotel for the cancellation time, date and conditions that apply. For all hotels, settlement at the hotel on departure is by cash or credit card. For a no-show, payable is a cancellation fee equivalent to the one-night deposit to guarantee the reservation at the rate confirmed on making the booking.

Climate and clothing: the conference is held at the end of the northern summer with temperatures of 8 - 20 °C. Participants should have warm clothing for evening events. Formal dress is not required for the conference business programme. For excursions and tours, casual wear is advised, and for the Gala Dinner, evening dress is preferable. Generally be prepared for rain.

Language: the official language in the UK is English.

Internet facilities and message board: Internet facilities will be available at the conference venue on 14 - 16 September 2009. Participants should check the message board outside the FIDIC 2009 Secretariat to receive and post messages.

Currency exchange: the legal tender in the UK is Pound sterling (GBP). Bank notes are available in denominations of £5, £10, £20 and £50, and coins in denominations of £2, £1, 50p, 20p, 10p, 5p, 2p and 1p. £1.00 = USD 1.65 = EUR 1.15, approximately. Travellers' cheques are usually accepted in large hotels, some restaurants and major stores. Otherwise, they must be cashed at an exchange office or bank. Foreign currency can be exchanged at exchange offices, banks, hotels and major department stores (always check the exchange rate as it varies greatly). Banks usually offer the best rate of exchange. Airports and major train stations also provide exchange services and automatic teller machines for cash withdrawals.

Credit cards: major credit cards are accepted everywhere, notably Visa, MasterCard and American Express.

Banking: official banking hours are 09.30 - 15.30, but most banks open until about 17.00.

Shopping: high-street shops are usually open 09.30 - 18.30, Monday - Saturday, with larger department stores open at 11.00 - 17.00 on Sunday. Large shopping centres may stay open later. Late-night shopping is available on Thursdays. Tax-free shopping is available at major UK airports.

Airports: London has five airports each with various combinations of train, Underground and bus services to central London.

Travel to London: London can be reached by air from virtually every major city. There are also high-speed Eurostar trains from continental Europe, numerous ferry crossings and a Channel Tunnel for those wishing to come by car from continental Europe.

Public transport: the Underground system, buses and taxis are the main modes of transport in London. Participants and Accompanying Persons will each receive an Oyster "pay as you go" card that can be used

on buses, the Underground, trams, the Docklands Light Railway, London Overground, and some National Rail services. Licensed taxis ("black cabs") can be hailed in the street or at designated ranks. Licensed private hire services (including minicabs) are a cheaper alternative to black cabs. They carry a distinctive TfL licence disc and must be booked through a licensed operator.

Driving in the UK: the minimum age for driving a car is 17 years, and drivers must have a valid, full national license or an International Driving Permit issued abroad. A visitor can drive for up to 12 months from the date of arrival provided the license or permit remains valid. Seat belts must be worn; drivers can be required by the police to provide a breath test. To rent a car, one must be at least 21 years old and have held a license for 12 months. Drivers under the age of 25 may incur a young driver surcharge; some car hire firms have a maximum age limit of 69 years old.

VAT: there is a 15% Value Added tax on many goods and services in the UK (but not for public transport, coach travel, air travel and taxi fares). Refunds on expenses incurred in the course of attending FIDIC 2009 London may be possible. Business persons based in the European Community need to complete a VAT65 form issued by the UK's HM Customs and Excise; VAT65A form is for a business person not established in the EC.

Tipping: most hotels and some restaurants include a service charge (usually about 10%). If it is not included a 10% tip is acceptable. Porterage: £1 per suitcase; taxis and hairdressers: 10%.

Power supply: UK power supply is 230/240 volts. Sockets accept only three-(square)-pin plugs, so an adapter is needed for continental European and US appliances.

Telephones and postal services: some payphones take coins from 10p and larger, and some accept Euro coins. However, most only use phonecards that can be purchased at many shops. Country calling cards and major credit/debit cards can also be used from most payphones. Most dual- and tri-band mobile phones with GSM 900 or 1800 will work via roaming. A UK prepaid mobile phone with a phone number and a SIM card costs approximately £30 in many high street shops. The emergency telephone number is 999 or 112.

Disclaimer and insurance: the organisers are not responsible for personal expenses incurred or loss suffered by a conference participant in connection with the event, and are not responsible for mishaps. Participants should make their own insurance arrangements, by taking out whichever insurance they consider necessary. For all events during the conference, the registration fees do not include provision for the insurance of participants against personal accidents, sickness, theft or property damages.

Conference Venue

FIDIC 2009 London takes place at the Queen Elizabeth II Conference Centre, Broad Sanctuary, Westminster, London SW1P 3EE. Uniquely situated in the shadow of Big Ben, Westminster Abbey and the London Eye, the fully air-conditioned centre offers the finest facilities that combine modern comfort with the latest in technology.

Westminster Underground Station on the Jubilee, Circle and District Lines (five minutes walk): exit the station via the underground tunnel towards Parliament Square (Exit 6) to reach the street level on Whitehall. Turn left into Parliament Square, cross the road and then turn right into Broad Sanctuary. The Centre is located on the right, directly opposite Westminster Abbey.

St James's Park Underground Station on the Circle and District Lines (five minutes walk): take the Broadway exit from the station and walk straight down Tothill Street. At the end of the street, turn left; the Centre is in front.
